Thank you for visiting our ADVANTAGE AUSTRIA booth at the Reflect Festival. We are delighted to participate for the first time as a partner country at the largest technology and startup event in Cyprus. The Reflect Festival provides a great platform for Austrian startups and scale-ups to take their next internationalization steps with reach into the SEE and MENA regions up to India.

The event is part of go-international, a joint initiative of the Austrian Federal Ministry for Economy, Energy and Tourism and the Austrian Federal Economic Chamber.

Known for summer, sun, beach, and vacation, many of Austria's Born Global Champions do not have the island on their radar as an innovation location. However, in the latest EU Innovation Scoreboard, Cyprus has risen from "Moderate Innovator" to "Strong Innovator" over the past six years with a performance increase of over 35 points. In comparison, Austria gained 6 points. The country is implementing targeted reform efforts for innovation as part of the Recovery and Resilience Plan. Seven of the total 38 EU Innovation Excellence Centers are located in Cyprus, each assured funding of 30 million euros for a period of seven years. Additionally, Cyprus's strategic location as a bridge between MENA and Southeast Europe, along with its low tax burden and double taxation agreements with over 60 countries, including Austria, make it an attractive innovation hub.

Austrian companies and startups with innovative use cases – from AI-based digitisation of building portfolios and a legal-tech platform for online hate protection to consult&GO business services as well as a one-stop tool for Ethereum node installation, setup, and management – are represented at our AUSTRIA booth and the Reflect Festival. All of them have one thing in common: they are interested in seizing new cooperation and growth opportunities in Cyprus.

The open-source Stereum software enables easy operation of nodes in minutes. An Ansible engine installs dependencies, secures firewalls and coordinates updates without downtime. Modular plugins can be used to add DVT clusters and custom Grafana visualizations. Advanced APIs provide Prometheus metrics and remote signer endpoints.

Community governance and transparent code reviews guarantee tested releases. StereumPlus transfers this philosophy to the cloud, with ISO-certified data centers and full root access. Together, Stereum and StereumPlus form an innovation stack for the Ethereum ecosystem that democratizes staking and accelerates the deployment of dApps.
