Key findings of the Austrian Business Confidence Survey 2021


- Feedback provided by 85 companies from the Austrian Business Circle in Egypt
- Business climate outlook for 2022 is extremely positive: 78 % expect improvement
- 72 % of companies expect rise in turnover, 66 % plan to (further) invest in Egypt
- Political stability and reducing bureaucracy are the top regulatory topics
- Infrastructure and professional qualifications in Egypt require improvements
- Overall, the corona crisis only had a moderately severe impact on companies
- 50 % of companies have not encountered problems with Egyptian customs






Q1: How would you characterise the current economic climate and state of the economy in Egypt?

Business climate in the next 12 months








Q2: Looking at your company's performance in the subsidiary's country, how would you assess the indicators listed below over the last 12 months?

Assessment of performance indicators for the previous 12 months








Q3: Looking at your company's performance in the subsidiary's country, how would you assess the indicators listed below over the next 12 months?




Top regulatory areas with potential for improvements








Q5: Looking at the factors listed below, in which three areas could your local market be made even more attractive for Austrian companies? Where is most room for improvement?











Q6: Looking at the services provided by your local Advantage Austria office, which do you value the most?








Q7 – Q9: Profiles of the participating companies: Main activities, annual turnover and export share of turnover.







Q10: Looking at the indicators listed below, how would you assess the impact of the Corona crisis on your company?








Q11: In the past 12 months, has your company encountered problems with Egyptian Customs during the import or export process?

Problems encountered with Egyptian Customs during the import or export process








Q12: Is your company planning to (further) invest in Egypt in the coming 12 months?
