

Bernd Wrabetz is an Austrian career diplomat and in August 2024, he was appointed Austrian Ambassador to the United Kingdom. In the course of his career he served at the Permanent Mission of Austria to the United Nations. New York, Austrian Embassy in London and as Special Assistant to the Executive Secretary of the Comprehensive Nuclear-Test-Ban Treaty Organization. From 2009 to 2013 he served as the Austrian Ambassador to Portugal and Cape Verde and from 2013 to 2016 as the Austrian Ambassador to India. Bangladesh, Bhutan, the Maldives, Nepal and Sri Lanka. Ambassador Wrabetz has also been the Foreign Policy Advisor for three federal Chancellors of Austria

Walter Ruck has been President of the Vienna Economic Chamber since 2014. He began his career representing the interests of Viennese companies at the Vienna Construction Guild in 2004. Since 1991, Ruck, who was born in Vienna, has been the Managing Director of the family construction company. Austria's capital Vienna is an economic powerhouse with more than 140,000 businesses contributing a quarter of Austria's GDP. It's the largest university city in the German-speaking world providing a fertile ground for a new generation of startups and the talent pool needed for hi-tech sectors such as life sciences.
