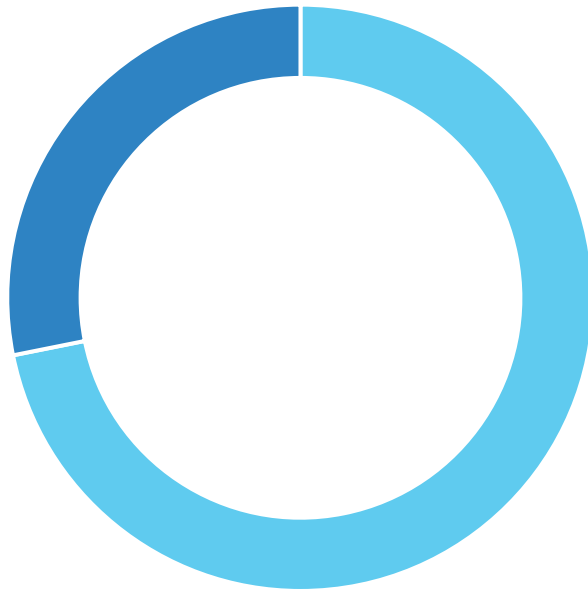

# Slovenia's recovery and resilience plan

**€2.5 billion**



■ Grants ■ Loans

Slovenia is expected to use €1.8 billion of available grants and about €705 million of loans from the Recovery and Resilience Facility (RRF).

The planned measures will support long-term sustainable growth and address the challenges of the green and digital transition.

# C1 - Green Transition

Components:

## **C1K1 - Renewable energy sources and energy efficiency**

- Energy efficient restructuring of RES-powered district energy systems using new technologies
- Strengthening the electricity distribution network
- Investments to increase energy efficiency in the economy

## **C1K2 - Sustainable building renovation**

## **C1K3 - Clean and safe environment**

- Social and economic resilience to climate-related disasters in the Republic of Slovenia
- Reducing flood risk and reducing the risk to other climate-related disasters
- Next Gen Forestry – establishment of the Centre for seeds, nurseries and forest protection
- Urban wastewater discharge and treatment projects
- Drinking water supply projects





## Development area C1 - Green Transition

Components:

### C1K4: Sustainable mobility

- Promoting the deployment of alternative fuels infrastructure in transport (network of electric vehicle charging points)
- Increasing rail infrastructure capacity (upgrading of the Grosuplje railway station, Ljubljana-Jesenice line and Ljubljana-Divača line)
- Digitisation of rail and road infrastructure

### C1K5 - Circular economy – resource efficiency

- Integrated strategic project for the decarbonisation of Slovenia through the transition to a circular economy
- Increased wood processing for a faster transition to a climate-neutral society

Estimated resources of the RRF for the implementation of investments in the development area of **Green Transition: €1.064 billion, of which €551.75 million from grants and €513 million from loans.**



## Development area C2 - Digital Transformation

Components:

### **C2K6 - Digital transformation of the economy**

- Industrial/Business Digital Transformation Programme
- Establishment of hybrid cloud infrastructure at the Ministry of Economic Development and Technology

### **C2K7 - Digital transformation of the public sector and the public administration**

- Digitalisation: public administration and the public sector; internal security; education, science and sports; environment and spatial planning; agriculture, food and forestry; culture; field of justice.
- Gigabit infrastructure (8,500 households)

Estimated resources of the RRF for the implementation of investments within the development area **Digital Transformation: €316.67 million from grants.**

## C3 - Smart, Sustainable, Inclusive Growth

Components:

### **C3K8 – Research, development and innovation**

- Improving the management and efficiency of public investment in R&D
- Establishment of the National Food Institute
- Co-financing research and innovation projects supporting green transition and digitalisation
- Co-financing of investments in RDI demonstration and pilot projects
- Co-financing of projects and programmes to enhance the international mobility of Slovenian researchers and research organisations

### **C3K9: Increasing productivity; investor-friendly business environment**

- Support for investment to increase productivity, competitiveness, resilience and decarbonisation of the economy, and to maintain and create jobs
- Establish innovative ecosystems of economic and business infrastructure

## C3 - Smart, Sustainable, Inclusive Growth

Components:

### **C3K10 – Labour market – measures to reduce the impact of negative structural trends**

- Structural measures to strengthen the labour market
- Supporting more flexible ways of organising work
- Introducing more flexible working methods
- Faster entry of young people into the labour market
- Training and education of employees

### **C3K11 – Sustainable development of tourism, including cultural heritage**

- Strengthening the sustainable development of tourism
- Sustainable development of the Slovenian tourist accommodation offers
- Sustainable development of public and shared tourism infrastructure
- Investments in infrastructure in the field of culture and cultural heritage





## C3 - Smart, Sustainable, Inclusive Growth

Components:

### **C3K12 – Strengthening competences, especially digital ones and those required in new jobs and green transition**

- Renovating the education system for the green and digital transition
- Comprehensive transformation of green and digital education
- Reform of higher education for a green and resilient transition
- Pilot projects for higher education reform for a green and resilient transition
- Modernisation of secondary vocational and vocational education training, including apprenticeships
- Strengthening cooperation between the education system and the labour market
- Greening education infrastructure in Slovenia

### **C3K13 – Efficient public institutions**

Estimated resources of the RRF for the implementation of investments within the "Smart, Sustainable and Inclusive Growth" development area: **€737.36 million**, of which **€663.99** from grants and **€73.37** million from loans.



## C4 - Healthcare and Social Security

### Components:

#### C4K14 – Healthcare

- Strengthening the competence of health personnel to ensure quality of care
- Digital transformation of healthcare
- Accessibility of the health system
- Effective treatment of infectious diseases (upgrade of the Clinic for Infectious Disease in Ljubljana and the construction of a new clinic in Maribor).

#### C4K15 – Long-term care

- Ensuring integrated treatment of persons in need of higher levels of LTC and more complex nursing services or continuous nursing care
- Ensuring a safe living environment for dependent persons

## **C4 - Healthcare and Social Security**

Component:

### **C4K16 – Social housing**

- Provision of public rental housing

Estimated resources of the RRF for the implementation of investments under the **Health and Social Security component: €363.9 million, of which €244.9 million from grants and €119 million from loans.**



# Implementation

€231 million

- Advance payment from the RRF

€117.1 million

- Directed to projects for increasing the capacity of railway infrastructure

€57 million

- The first installment for the payment of the grant - expected in spring of 2022
