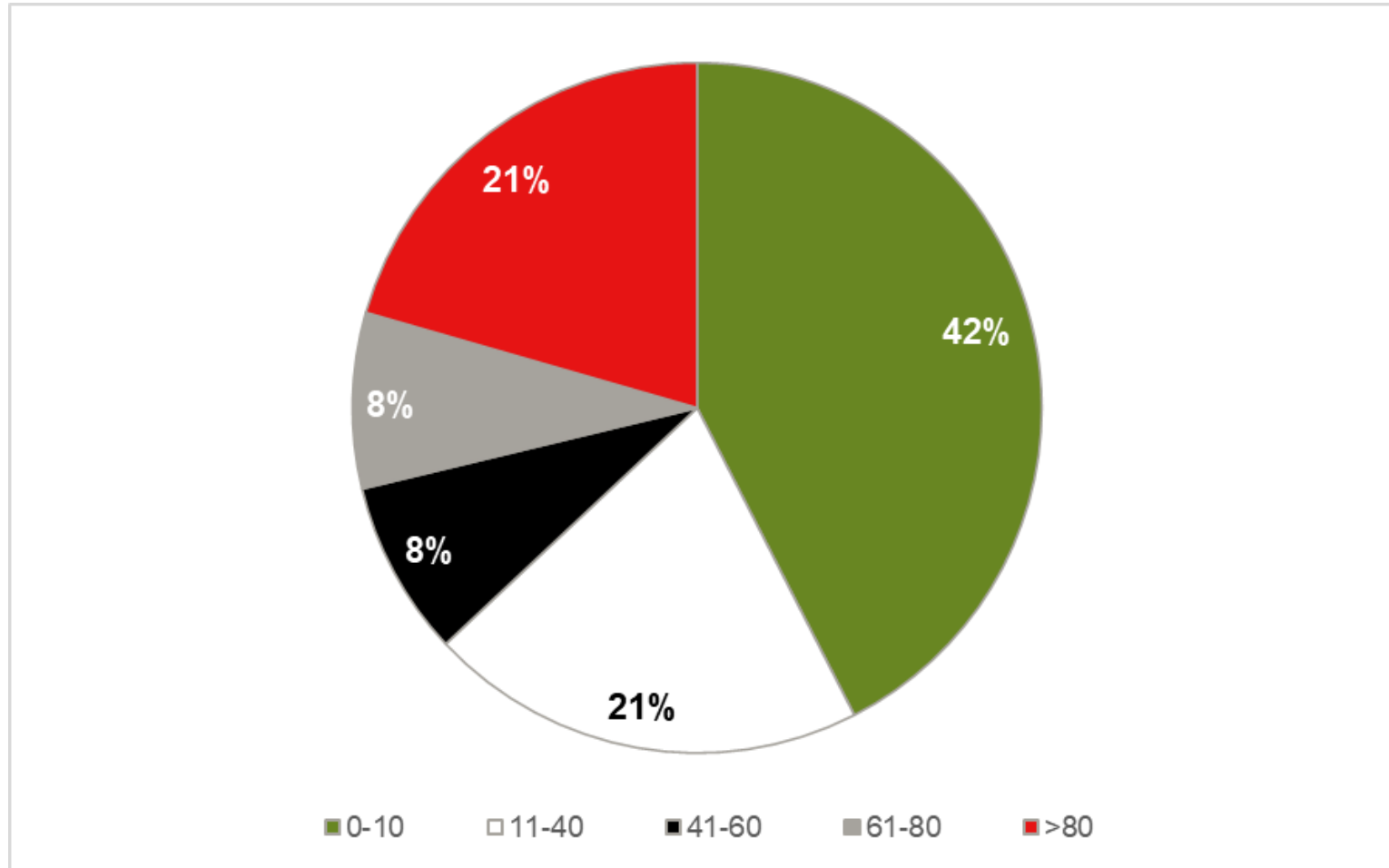

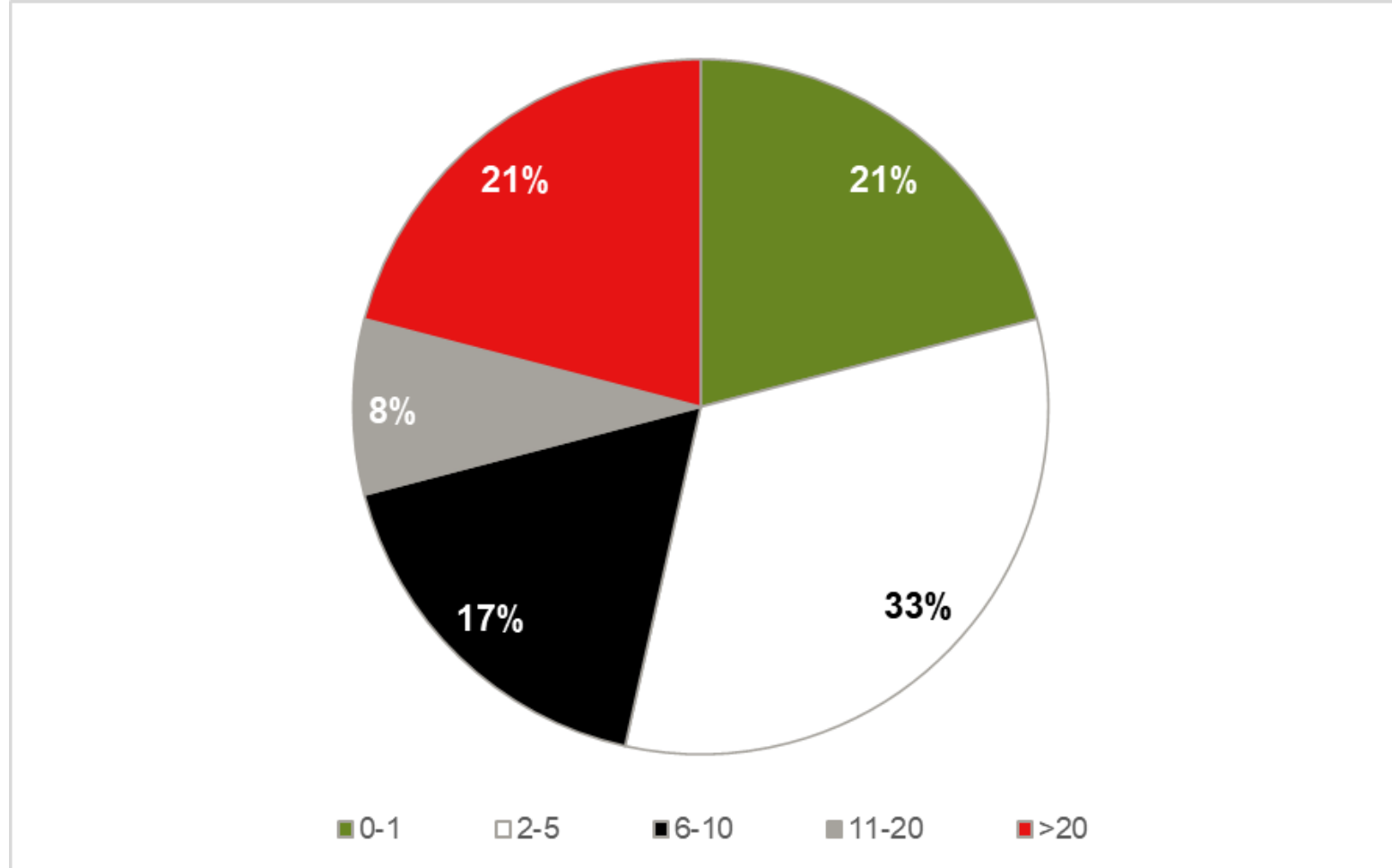

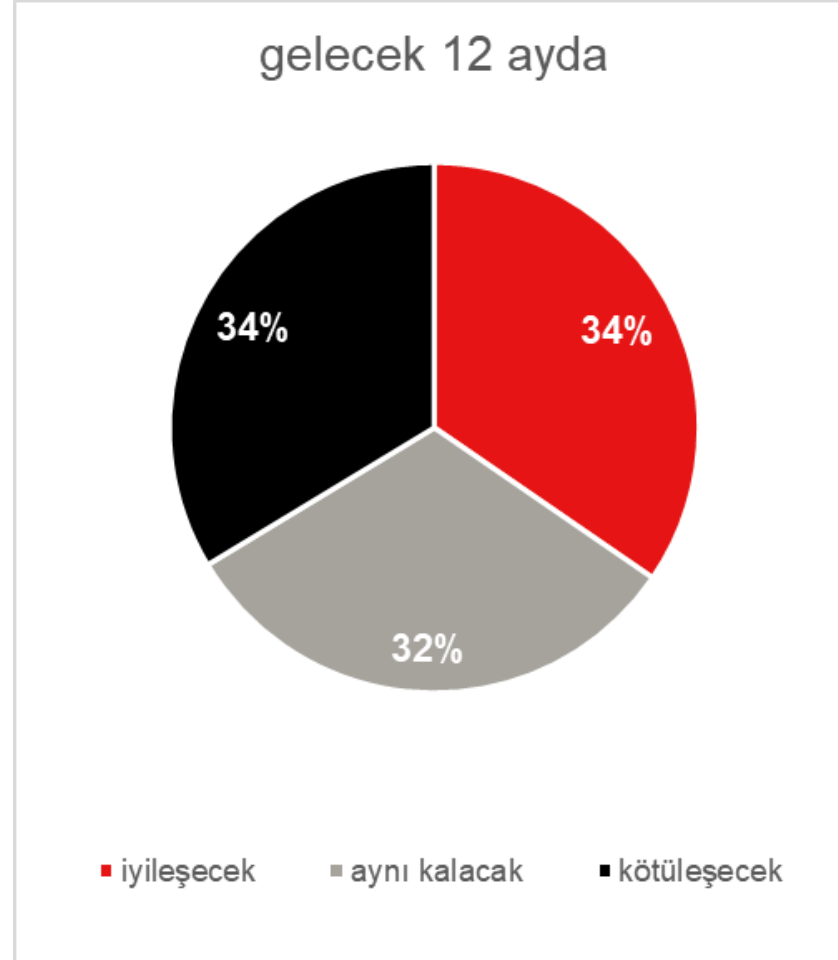
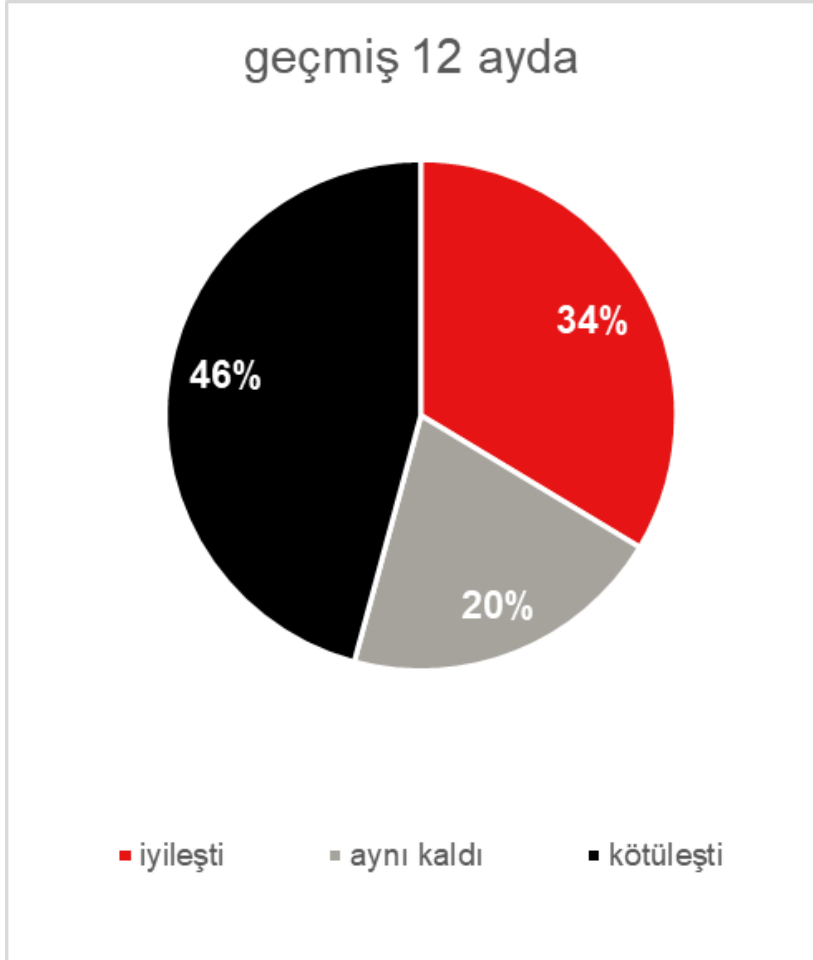
Soru 9: İhracatınızın toplam cironuza oranı (%) (isteğe bağlı soru) (% of Exports)



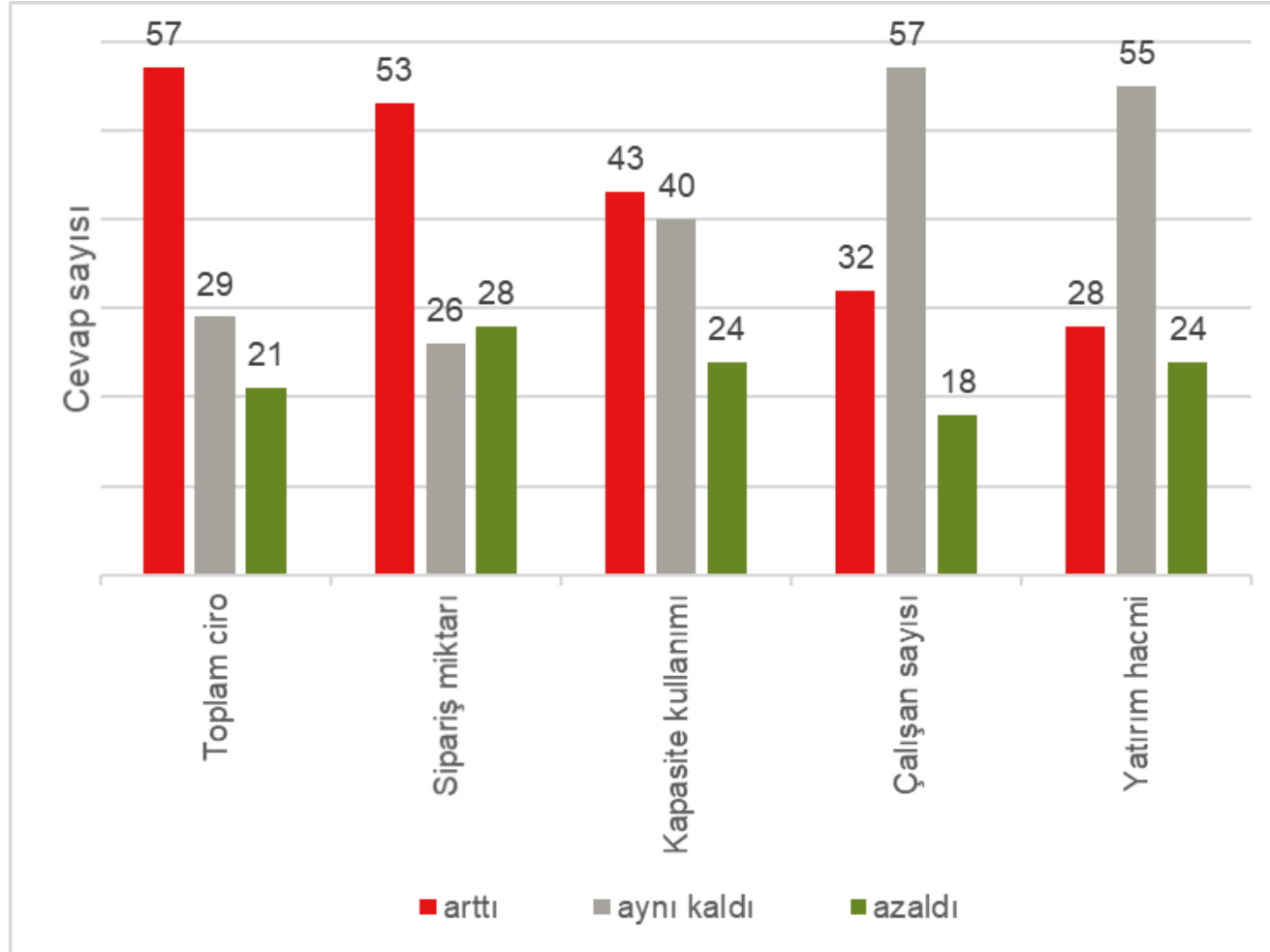
Soru 8: Şirketinizin Türkiye'deki yıllık cirosu | milyon EUR: (isteğe bağlı soru)
(Turnover of your company in Turkey)



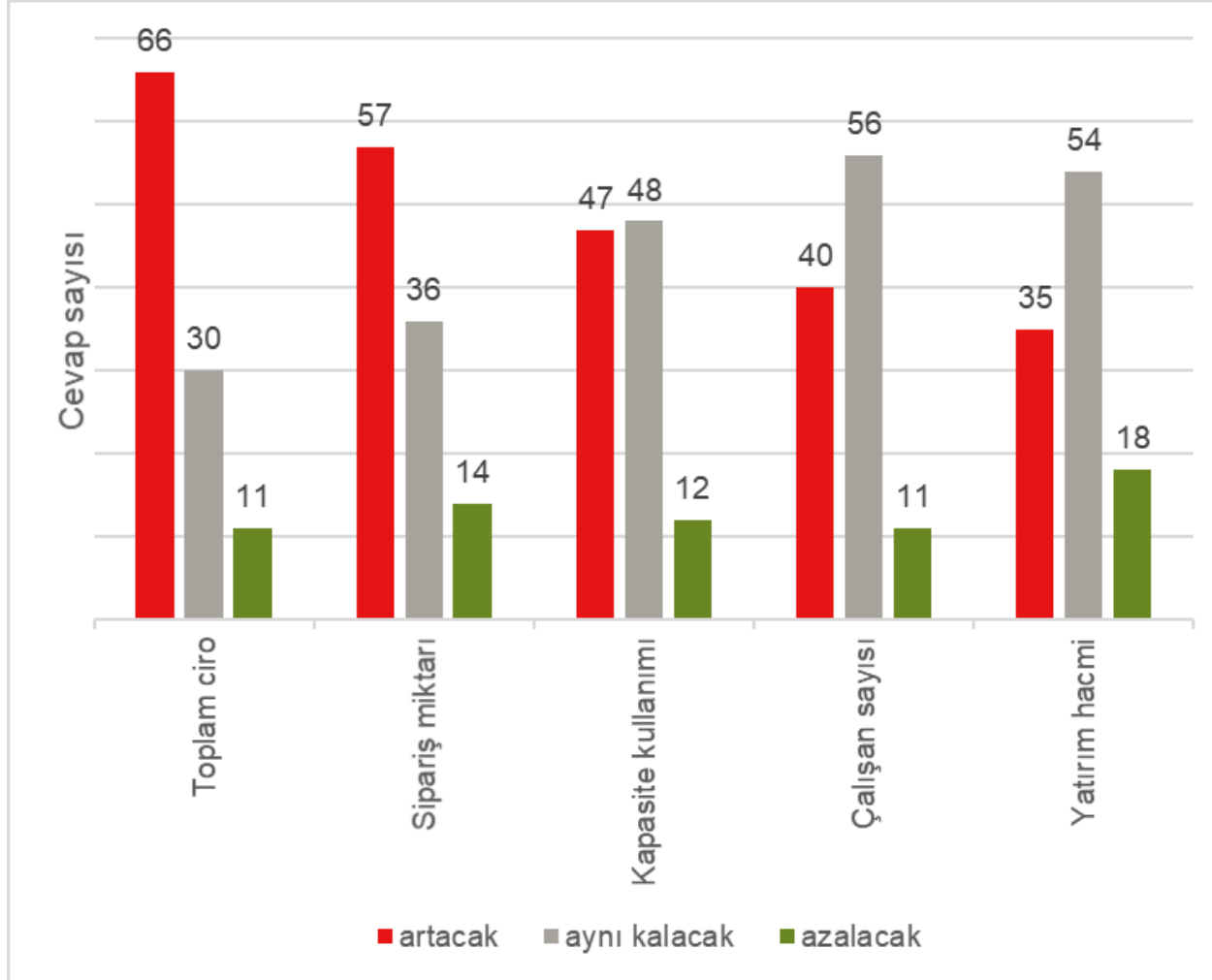

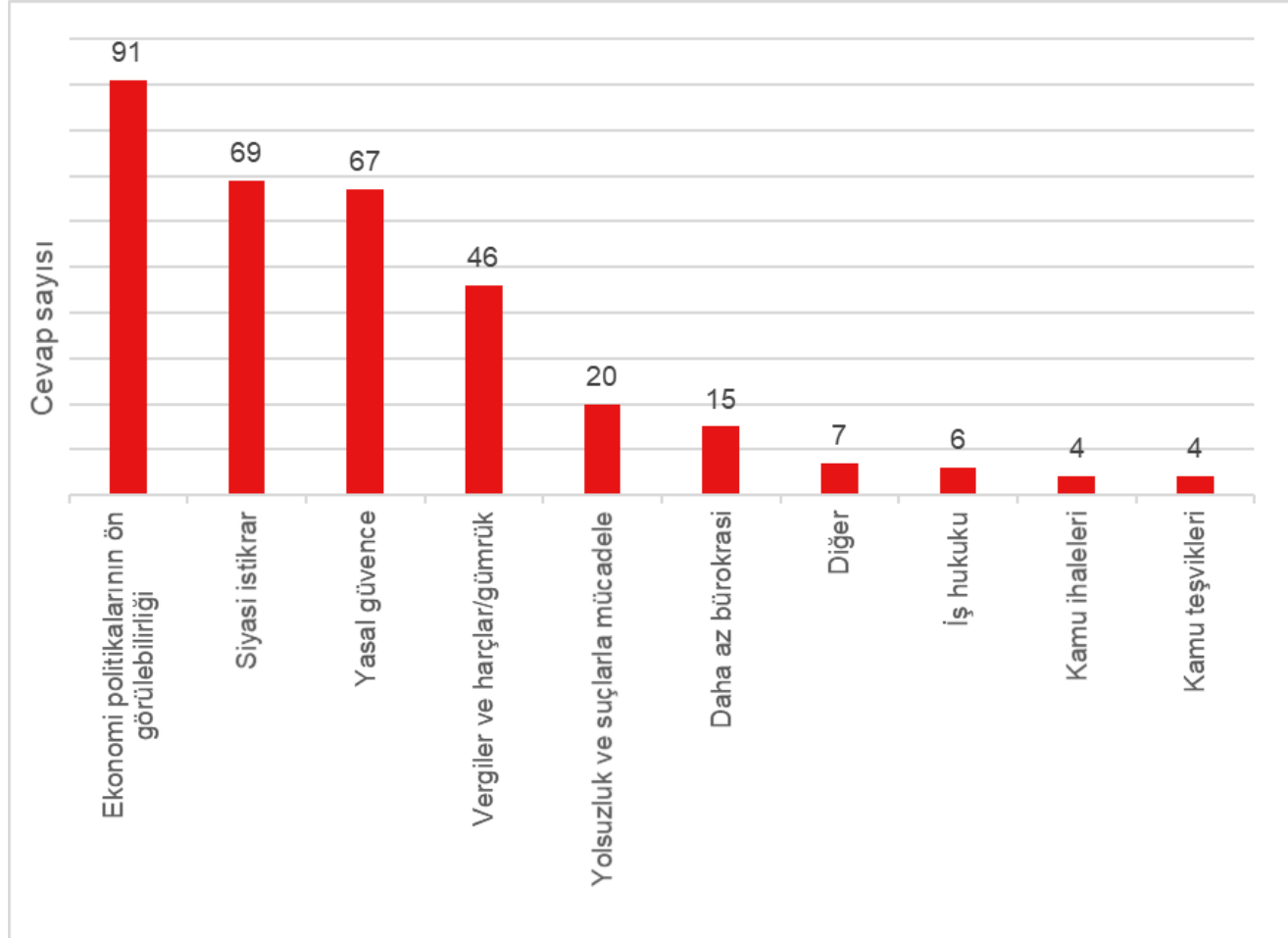

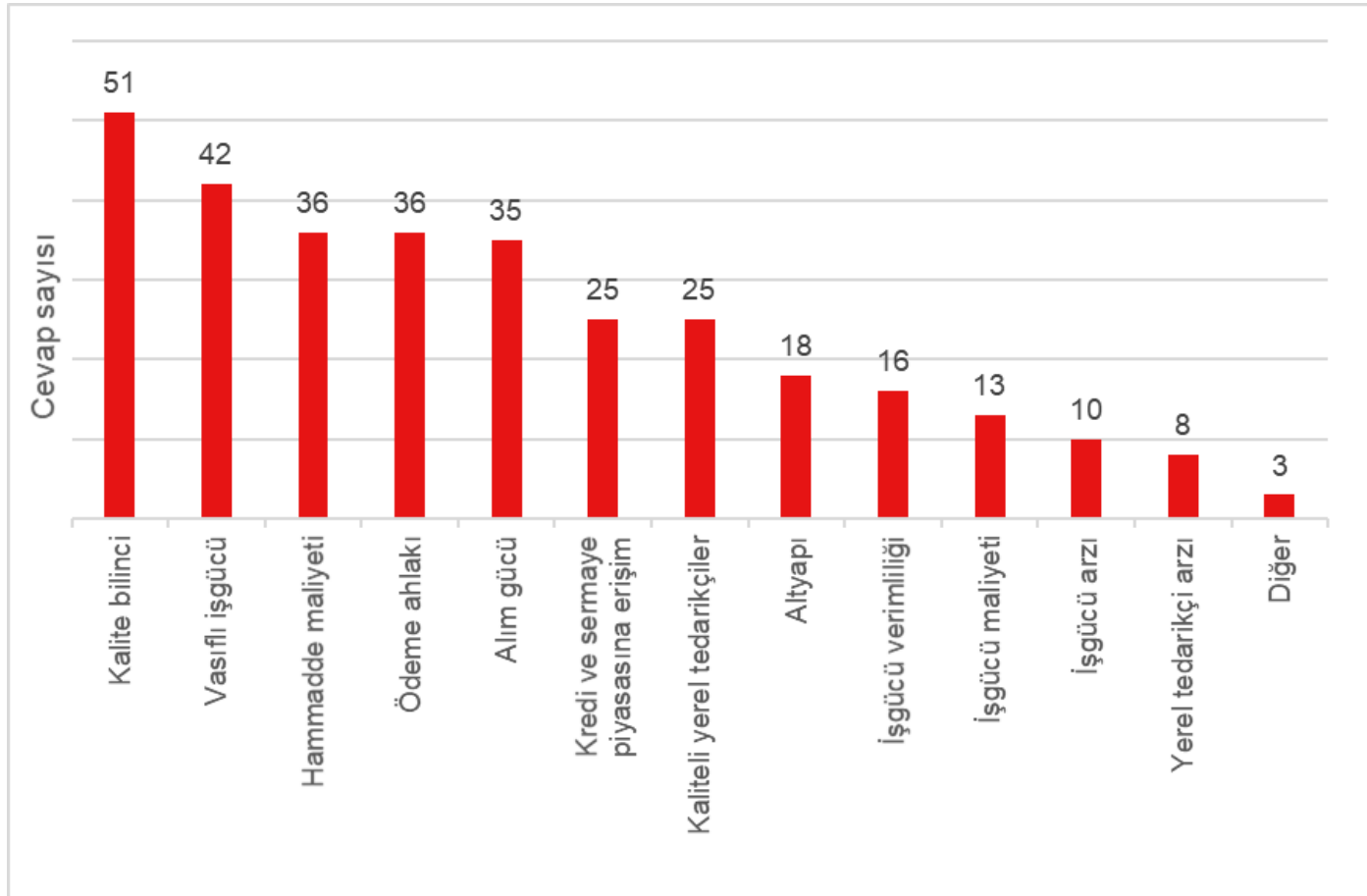

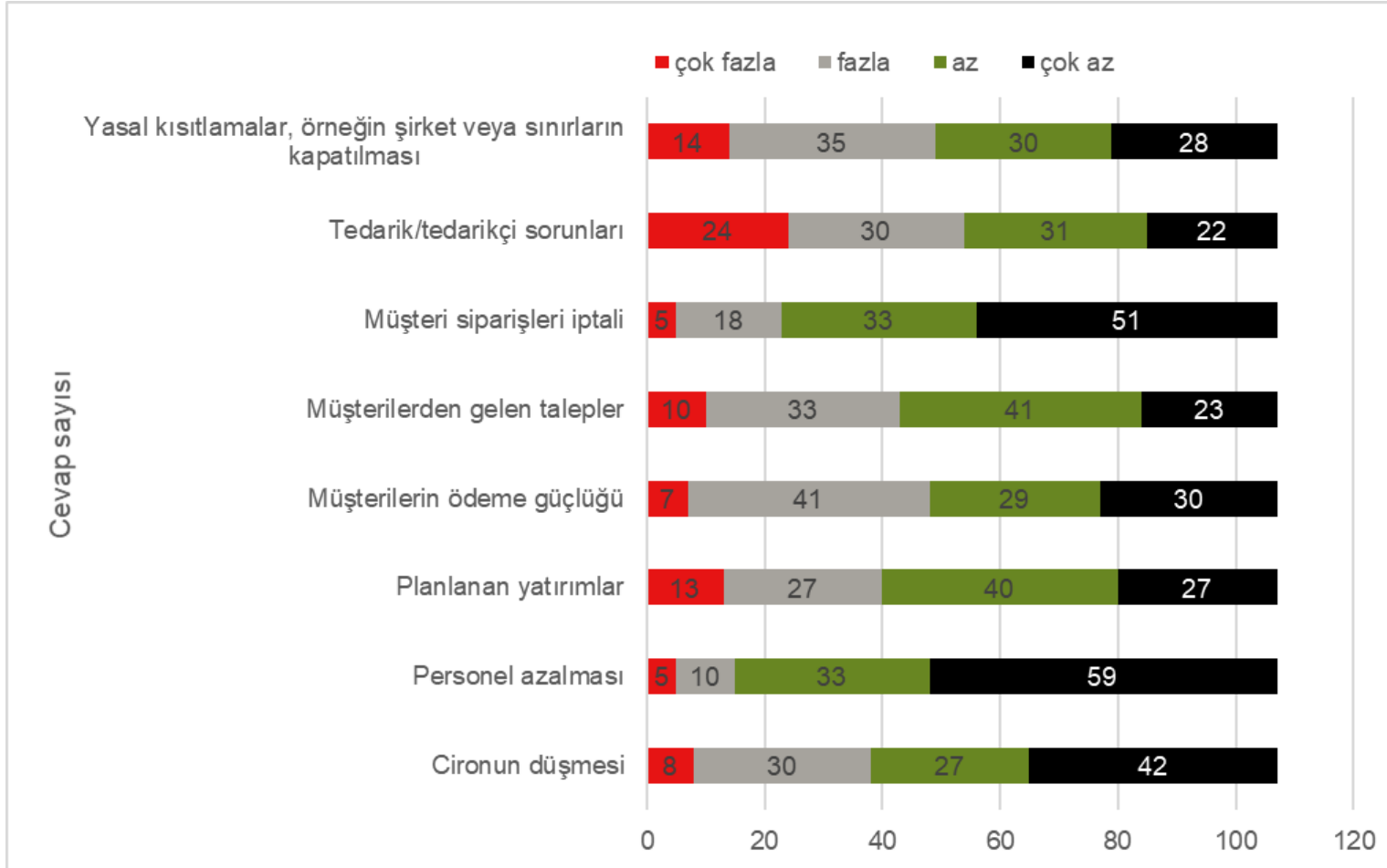

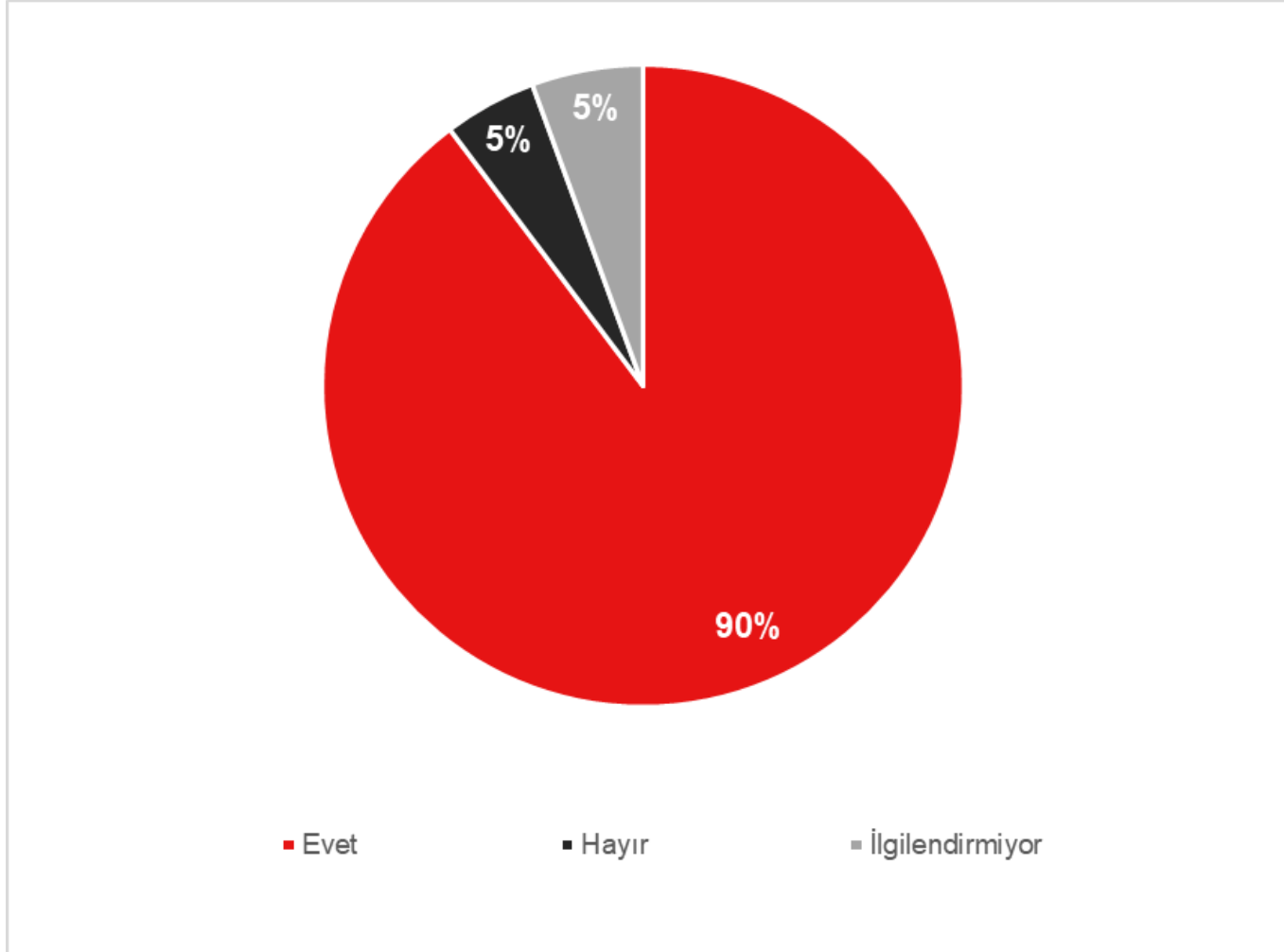

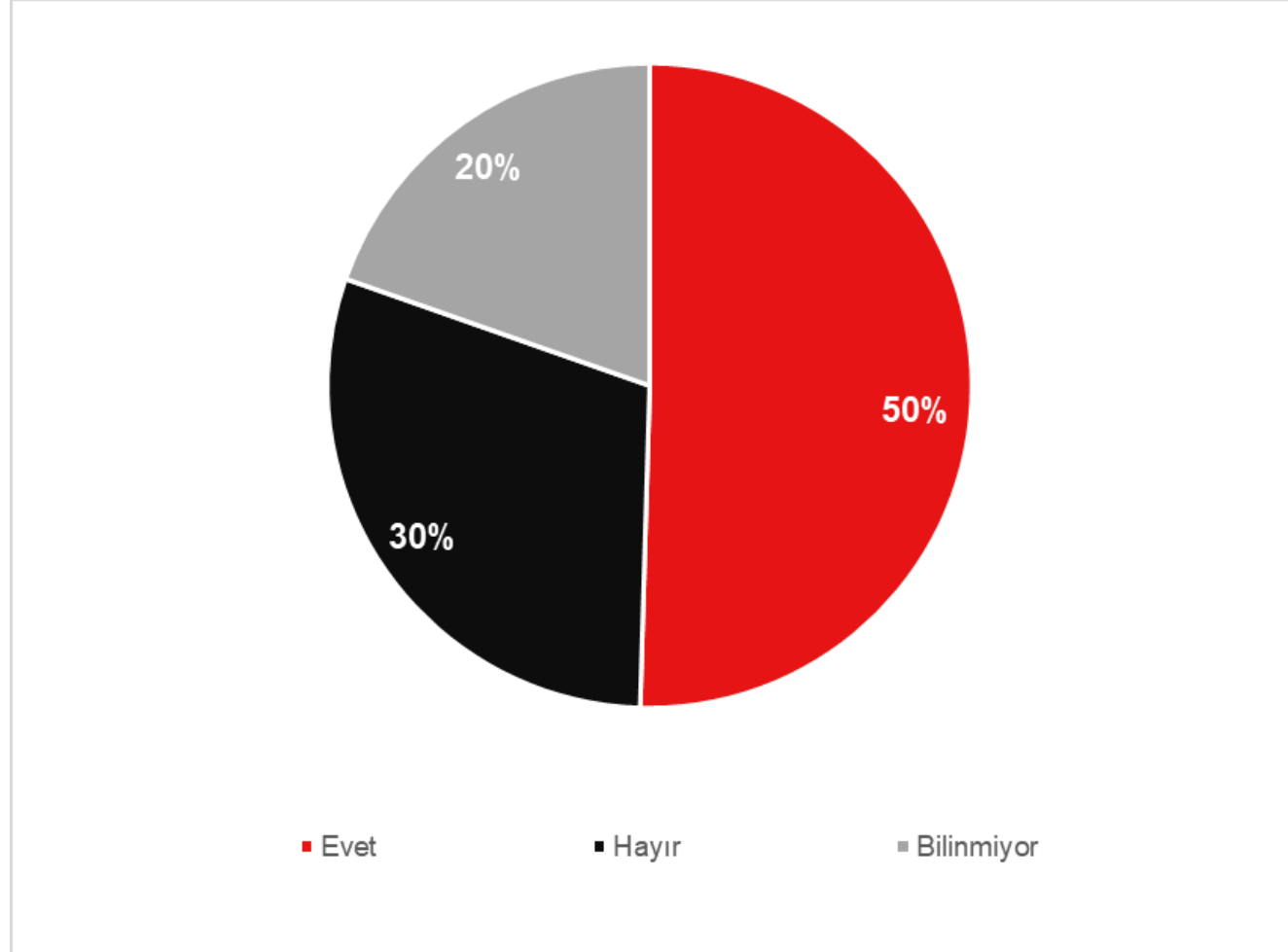

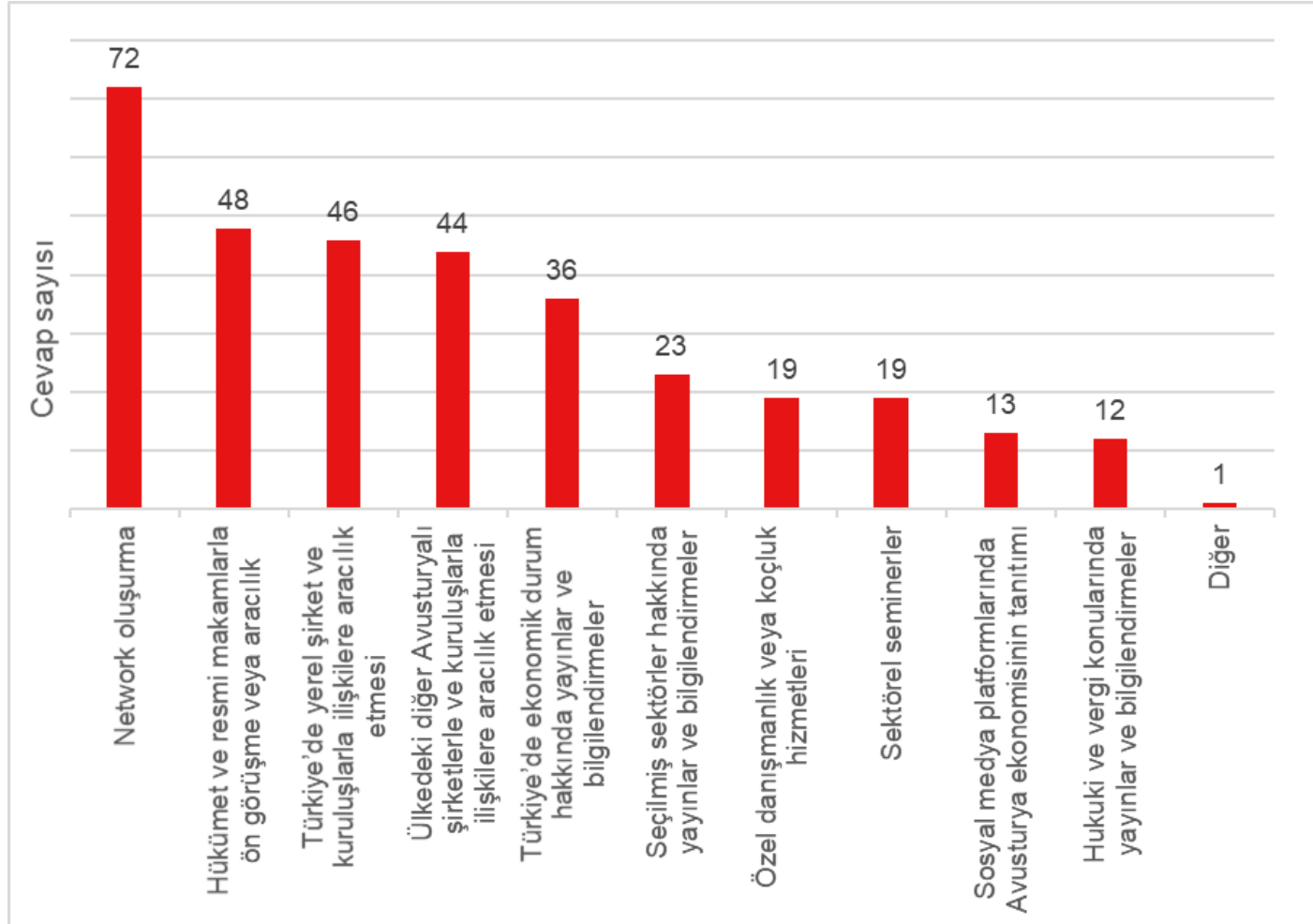
